2007 CLUB/TEAM SPONSORSHIP CONTRACT

This is to be a mutually beneficial agreement between Trisports.com L.L.C., an Arizona limited liability company, doing business as TriSports.com, with principal offices at 4495 Coach Dr., Tucson, AZ 85714 and _____(Team Name, Team Contact Name), in which each party will commit to the following:

TRISPORTS.COM COMMITMENT

1. TriSports.com will give the Club/Team an allocation of product, including stickers, water bottles and other promotional material. The specific allocation will be discussed after your acceptance of our Sponsorship.
2. Team TriSports.com sponsorship is valid for two (2) calendar years. Your sponsorship will not automatically roll over to the following year. This contract is valid from date of TriSports.com authorization until December 31 of the following year.

CLUB/TEAM COMMITMENT

1. TriSports.com will be your exclusive triathlon and multisport equipment supplier. You agree not to accept sponsorships from other triathlon, multisport, or related stores. We do understand that Clubs/Teams may have a local bike, run, or swim shop as a sponsor.
2. The TriSports.com logo will be placed on all official competitive apparel. TriSports.com will not be required to pay for placement of our logo on any Official Club Clothing. In addition, we will provide TriSports.com stickers for members to place on sports equipment (if they so desire).
3. Items provided to you by TriSports.com will not be resold.
4. Club/team members will promote the TriSports.com name, and when possible, educate the public on the attributes of products carried by TriSports.com.
5. Club/Team members will not defame or disparage TriSports.com or products we carry. Club/Team members will also agree to use reasonable care to avoid injury to people or damage to property in the course of your participation in any event or activity supported or sponsored by TriSports.com. 8. Club/Team Contact warrants that member or their representative is of legal age and has every right to contract in his/her own name in the above regard. He/she has read the above consent and release, prior to its execution, and is fully familiar with and agrees to the contents thereof.
